We would like to welcome you to our Burke Allergy & Asthma Center. Thank you for selecting us to meet your healthcare needs.

Please find enclosed a medical history sheet and insurance registration form. Please complete and return them to our office on the day of your appointment.

Your initial visit will require about one to one and a half hours depending upon the complexity of your condition. Usually, the allergy skin testing is performed on the first visit. **Three** days prior to your appointment, you should stop taking antihistamines, such as **Allegra, Zyrtec, Alavert, Benadryl, Actifed, Tavist and Chlor-Trimeton**. If you are taking **Claritin** or **Clarinex**, you should stop taking it **five** days prior to your appointment.

## **Office Policies Regarding Insurance Coverage**

### **Confirmation of Eligibility:**

If you do not know your allergy/asthma health insurance plan benefit coverage, you should contact your insurance company for an explanation of your coverage benefits/deductible/co-pay, etc., according to your contract with them.

### **Filing a Claim:**

You should bring a copy of your health insurance card to evaluate your eligibility in order to provide you with an insurance verification form. We will be happy to file for you to facilitate payment.

### **Deductible/ Co-pay/ Patient Portion**

All payments such as deductible/ co-pay/ patient portion should be made by the patient/parent at the time medical services are rendered. If you do not have insurance, full payment is expected at the time of the visit.

Please understand that YOU are financially responsible for all services rendered.

We keep your account updated in our office regardless of your Insurance payments.

We are eager to help you receive the maximum reimbursement from your health insurance according to your contract and the services rendered.

### **From McLean, VA (Tysons Corner):**

Take 495 South to Exit 54-A (Braddock Road West)

From Alexandria, VA

Take 495 North to Exit 54-A (Braddock Road West)

Drive through 4 traffic lights. At the 5th light, turn LEFT on Burke Lake Road.

Go through 3 traffic lights and drive over the overpass.

At the next light, turn LEFT on Burke Road.

Turn LEFT into the Burke Village Shopping Center. (Burke Post Office will be on the right.)

Giant Food is at one end of the shopping center.

Our office is at the opposite end (across from Taco Bell/KFC).

### **Fairfax County Parkway (Rt. 7100):**

From Fairfax/Reston area, take 7100 South (towards Springfield):

Turn LEFT on Burke Centre Parkway. Turn LEFT on Burke Lake Road.

Turn RIGHT on Burke Road.

Turn LEFT into Burke Village Shopping Center (see last step above).

From Springfield area take 7100 North towards Fairfax:

Turn RIGHT on Burke Lake Road.

Go through 3 lights. At the 4th light, turn RIGHT on Burke Road.

Turn LEFT into Burke Village Shopping Center (see last step above).
